INCT-InEAC National Institute of Comparative Studies in Conflict Management

PRESENTATION

The National Institute of Comparative Studies in Conflict Management (INCT-InEAC) was approved in February 2009, by the Ministry of Science and Technology and Innovation, through the initiative of the "Institutes of Science and Technology" Program – Call for projects 15/08, proposed by CNPq in partnership with CAPES/FAPERJ. It was part of a set of 126 INCTs eventually approved, of which two were approved in the induced area of Public Safety. One of them was InEAC, the only INCT at the time based at the Fluminense Federal University (UFF). Currently, InEAC has approved in 2014 a second project in the public call MCTI CNPq/CAPES/FAP No. 16/2014 - INCT Program, financed from December 2016 to December 2022.

In general, the National Institutes of Science and Technology Program has among its goals the mobilization and articulation of the best research groups in frontier areas of science and in strategic areas for the country's sustainable development, to promote basic and fundamentally competitive international scientific research, to support the installation and operation of laboratories in educational and research institutions and enterprises, and to contribute to the improvement of science education and to the diffusion of science to the wider public.

Headquartered at the Nucleus of Teaching, Research and Extension on Comparative Studies in Institutional Conflict Management (NEPEAC), in Niterói (RJ), linked to the UFF Vice-Rectory of Graduate Studies, Research and Innovation (PROPPI), INCT-InEAC is consolidating a national and international network of training and research integrated by graduate programs and research centers of institutions from 07 countries and 06 Brazilian states. This network has been working in the area of Public Security and Criminal Justice since the year 2000, through various activities, such as the organization of seminars and participation in academic events and public hearings, development of research projects, participation in international cooperation agreements, Research and Development (P&D) projects, joint publications and Extension and Specialization courses.

Among other results, INCT-InEAC collaborates with innovation in social technologies aimed at conflicts' management processes in Brazilian society, both from a theoretical point of view and from the point of view of its application and implementation through the interaction promoted between the academia and social actors in the various contexts where they are required.


